## Work Health and Safety Policy

This management system including this policy applies to all Bernipave operations and workers across all Bernipave sites.

### Objectives

- Ensure our health and safety management system is appropriate to the nature and scale of Bernipave operations and specific risks and is adapted for relevance at all Bernipave sites.
- Comply with all relevant work health and safety legislation, regulations, standards, codes of conduct and other requirements placed upon Bernipave.
- Develop and implement safe working practices that are supported by documented and audited standards and procedures.
- Management commitment to the establishment of measurable WHS objectives and targets to measure, report, reassess and continually improve our work health and safety performance aimed at the elimination of work-related hazards/risks, injury and illness.
- Keep the workplace in a safe and healthy condition.
- Provide adequate training to all workers with respect to their responsibilities for safety to ensure they can competently perform their duties.
- Provide information to all workers including sub-contractors and visitors that inform them of health and safety issues relevant to Bernipave operations.
- Provide rehabilitation assistance to encourage a safe and timely return to work for recovering workers.

### Responsibilities

#### Top Management will ensure that:

- Exercise due diligence to ensure the health and safety of key stakeholders including workers, sub-contractors, customers and the general community.
- Provide the appropriate human resources, skills, technology and financial resources to ensure our work health and safety objectives can be met.
- Implement a WHS management system that complies with all relevant legislative, regulatory, standards and other requirements imposed on Bernipave.
- Consult with workers on all issues that may impact on their health, safety and well-being.

#### Workers will ensure that they:

- Comply with all WHS legislation, Bernipave WHS policies, procedures and management instructions.
- Work safely at all times to ensure their acts or omissions do not adversely affect the health and safety of themselves or others.
- Report all hazards/risks and incidents as soon as practicably possible.
- Participate in WHS training, consultation and initiatives to continually improve work health and safety outcomes.
